
Tamarack Golf Club is participating in the <u>Valley Green Fees Program</u> for the year 2016. Below is a sample of our 2016 Annual Membership card that each 2065 paid member shall receive. These can be picked up in the proshop when payment for your annual dues are received.



Statement of Program: Each participating golf club will offer members of participating clubs golf play at their course for ½ price green fees. This benefit will be extended to members and at most courses, one guest for the year 2016. The benefit to be valid at anytime the golf course is open for regular play and tee times are available. Exclusions to this benefit are holidays, weekends if indicated, or days that course events (tournaments, etc.) prevent visitor play. Golfers playing in tournaments at participating golf clubs will pay normal tournament fees and are not entitled to ½ price benefit. (Example: Cost at 2016 Memorial tournament in LaJunta was \$160.00/golfer. All golfers pay this fee, NOT \$80.00).

Membership Responsibilities: Participating members shall call ahead to schedule play and to insure space availability. They will inform course personnel that they are a member of TAMARACK GC and would like the ½ price green fees. Upon arrival they shall present their membership card, pay appropriate green fees and play their round of golf, abiding and respecting all course rules. It is hoped that if a member is unable to contact the course ahead, that the course will honor the benefit if space is available. Please do not rely on acceptability of this privilege if the course is not contacted!

<u>Concerns or issues:</u> If a member experiences a problem at any participating course, they shall inform their home club and explain details. They shall not raise issues at the participating course. Club personnel will contact Tamarack Golf Club about any issues or concerns about the program. Every effort will be made to resolve the issues and Tamarack Golf Club will have the final say on resulting actions taken.
